HAZARDS IDENTIFICATION

CAUTION: KEEP OUT OF REACH OF CHILDREN

Free flowing granules with slight aromatic odor. Primary routes of entry are inhalation and skin contact.

SECTION 4

FIRST AID MEASURES

EYES: Hold eyelids open and flush with a steady, gentle stream of water for at least 15 minutes. Seek medical attention.

SKIN: In case of contact, immediately wash with plenty of soap and water for at least 15 minutes. Seek medical attention. Remove contaminated clothing and shoes while washing. Clean contaminated clothing and shoes before re-use or discard if they cannot be thoroughly cleaned.

INGESTION: If victim is conscious and alert, give 2-3 glasses of milk or water to drink. Avoid alcohol. Do not induce vomiting or give anything by mouth to an unconscious person. Seek immediate medical attention. Do not leave victim unattended.
